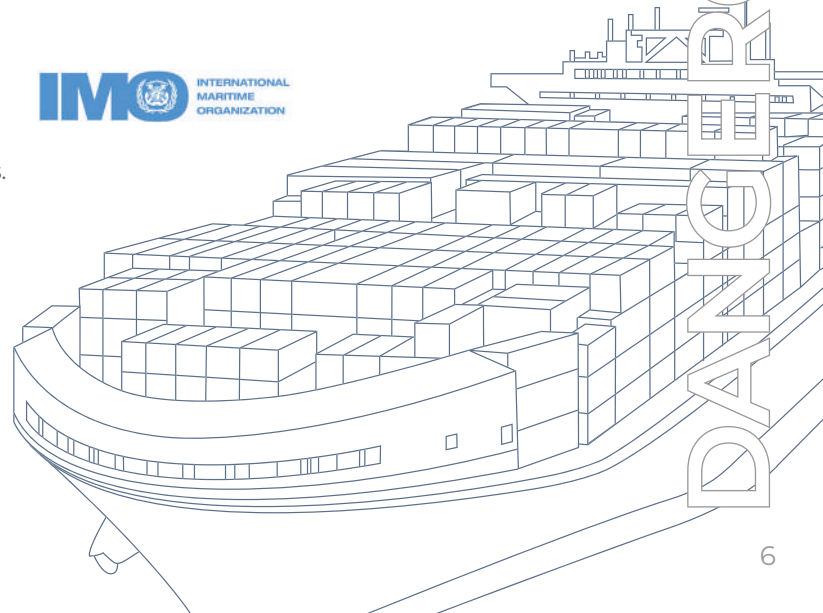
Maritime Dangerous Goods
